

Terms and Conditions

1. The Promoter

Dixons Travel, 1 Portal Way, London, W3 6RS, in partnership with lastminute.com.

The Gift and Prize Draw is operated by **LMnext UK Ltd** ("**lastminute.com**") at 77 Hatton Garden, London, EC1N 8JS.

These subjects can be considered as Joint Promoters according to Rule 8.17.9 of the CAP Code.

2. The Promotion

2.1 . Only one entry per transaction per person per week. A Participant may not enter on behalf of someone else. The Promoter reserves the right to request such information as it considers reasonably necessary or desirable for the purpose of verifying the eligibility or validity of an entry and any prize/gift may be withheld unless and until the Promoter is satisfied with the verification.

2.2 The Promotion is open for qualifying purchases made between 20/06/18 and midnight on 14/08/18 (the "**Promotional Period**") from Dixons Travel shops located in England, Wales and Scotland. Purchases made online on dixonstravel.com are excluded from the Promotion. Gift/Prize redemptions can be made on the promotional website <http://discount.lastminute.com> between 20/06/18 and 14/10/18 (the "**Redemption End Date**"). Entries received after the Redemption End Date will not be accepted by the Promoter.

2.3 To enter this promotion, Participants are required to make a purchase within a Dixons Travel store in the United Kingdom (excluding Northern Ireland) during the Promotional Period. Submit the required information on the promotional website <http://discount.lastminute.com>, using the lastminute.com registration PIN CODE *DTSUMMERGIVEAWAY* found on your till receipt. Please retain your till receipt as proof of purchase. Participant will be required to insert the registration PIN code and all the mandatory information on the website <http://discount.lastminute.com> to receive their guaranteed gift consisting of a £20 flight + hotel discount voucher to be used on lastminute.com.

Every Participants will enter in the final prize draw operated by lastminute.com consisting of 25 free flights for 2 passengers up to a maximum commercial value of £200 and 1 headline prize consisting of a holiday package for up to 4 people up to the maximum commercial value of £5,000.

2.4 The Promoters shall not be liable for any loss or corruption of data in transit.

3. The Prizes/Gifts

3.1 The prizes consist of:

3.1.1 **TIER 3 GIFT:** a guaranteed gift for every Participant when registering with the PIN code *DTSUMMERGIVEAWAY* on <https://discount.lastminute.com>, consisting of a £20 flight + hotel discount voucher. Customers are directed to the website (<http://discount.lastminute.com/>) where they can register the PIN code and fill in the compulsory fields (name, surname, sex, age, city, email address, telephone number). After customers enter this information and click the 'Register' button, they will receive an email to the address entered in the form, which will include the discount voucher code of £20 valid to book a Flight+Hotel package on www.lastminute.com with all the information to use it.

- The voucher is only valid for use on our website www.lastminute.com section "Flight + Hotel" and not for the holiday packages included on the website www.lastminute.com section "Holidays".
- The voucher is to be used by 30/04/2019.
- The voucher cannot be sold.
- The voucher cannot be combined with other discounts, cashback activities or promotions.

- The voucher is not refundable, it cannot be exchanged for cash or other goods and services.

3.1.2 **TIER 2 PRIZE:** 25 free return flights vouchers to book a flight for 2 passengers from the UK to European destinations (worth maximum commercial value of £200, with an array of flights to choose from, no domestic flights).

- The code can be used only on the dedicated website <http://freeflights2.lastminute.com> to book a return flight for 2 passengers from the UK to a European destination (no domestic flights);
- The code valid to book the Free Flight does not include additional flight costs (for example: warranty costs, check-in luggage, change name);
- At least one passenger must be above the age of 18;
- The code is to be used before, and not after 30/04/2019;
- The code will entitle the winner to pick from an array of flights with up to 10 months in advance (depending on the current flights availability for the selected departure, destination and periods).
- The code has a maximum commercial value of £200;
- The available flights are the same as offered by lastminute.com group properties (directly acceding through lastminute.com website and without any redirect from the possible offers on metasearch websites);
- The code is valid for one booking only. Once you use it, you cannot use it again or receive any leftover credit;
- It is possible to request the cancellation of the flight booking made with a voucher, but in doing so you forfeit your right to any form of reimbursement; any change fees are established by the selected and reserved airlines;

3.1.3 **TIER 1 PRIZE:** 1 holiday package for up to 4 people up to 7 nights' with destination to choose (Orlando, NYC, LA, Cape Town, Nice, Crete, Majorca and Tenerife) up to the maximum commercial value of £5,000.

Accommodation: Includes up to 7 nights' accommodation for up to 4 people, on room only basis, with 2 people sharing twin / double rooms or a family room where available, in a 4* hotel. B&B service may not be included, as per individual hotel fare rules, which will be made available to customers at the time of booking.

Flights: Includes up to 4 round trip flight tickets in Economy class to selected destination. Direct flights are not guaranteed. Flight tickets are valid from London airports only. Other airports can be requested provided they fall within the maximum commercial value. One check-in luggage per person will be included in your flight ticket, as per the individual ticket fare rules.

Booking & travel period: the Flight + Hotel package must be booked by 30/04/2019 and at least 2 months in advance of intended travel dates and is subject to availability of the package within the maximum commercial value. No travel permitted during Christmas and Easter holidays.

The reservations will be with a lastminute.com travel agent. If the winner wants to request the reservation, the winner has to type the website <http://book.lastminute.com.com> and insert the voucher code.

A registration form will open where the winner has to fill in all the details of their reservation request: name and last name, mail address, telephone number, 3 different departure dates, departure airport

(London unless otherwise agreed), the age of the passengers and any notes. After the completion of form, the winner has to click on the button “Send your booking request” in order to confirm his preferences. At least one passenger has to be an adult.

3.1.4 Tier 1 Prize will be won by 1 winner, Tier 2 Prizes by 25 winners and Tier 3 Gifts by all the registered customers during the Prize Draw Period on <https://discount.lastminute.com>.

3.2 The Prizes exclude all additional costs not included in the Prizes’ description, including but not limited to, travel to the departing airport (e.g. if the winner lives in Glasgow and the departure airport is Cardiff, the travel from Glasgow to Cardiff has to be paid by the winner), transportation to and from a hotel/airport, personal insurance, personal expenses such as food, drink, spa treatments, visas, check-in luggage, change name or booking cancellation. 3.10 The customer can request voluntary cancellation of the prize booked, however if any cancellation is permitted, no refund will be provided to the Customer.

3.11 In case of cancellation of a flight by the airline company, lastminute.com.com will provide a suitable alternative flight for the Customer without additional cost to the Customer.

3.12 Once the voucher has been issued it is solely the responsibility of the participant to ensure they secure and redeem it accordingly. Neither the promoter nor lastminute.com.com shall be held liable in the event of lost, stolen or unclaimed vouchers etc.

Registrations are open until 28/08/2018: after this date the PIN code will not be valid anymore and it will not be possible to enter in the Prize Draw. After the clicking on the "Register" button, participants will receive by email (at the same address they inserted on the website) their guaranteed gift consisting of a £20 flight + hotel discount voucher to be used on lastminute.com by 30/04/2019 and they will enter automatically into the Prize Draw.

4.3 By entering the prize draw, entrants will be deemed to have accepted and agreed to be bound by Dixons Travels and lastminute.com terms and conditions.

7. Liability

7.1 No responsibility can be accepted by the Promoters for any incomplete or illegible entries or any entries not received or corrupted during transmission, for whatever reason.

7.2 The Promoters shall have no liability for system failures on the Promoters's website or any third party websites.

7.3 The Promoters and its associated agencies and companies accept no liability for any loss, expense or damage which is suffered or sustained, whether arising from any Winner negligence, in connection with the promotion and/or Prize.

8.8 The Data Controller will make sure that all personal data supplied thereto is not disclosed and is processed in such a way as to guarantee its security and confidentiality, as well as to prevent unauthorized access thereto. All personal data and information provided by Entrants may be communicated, for the purposes set out above, to the following categories of parties:

10. Information about cookies

Cookies are small files which are stored on your computer, they hold a modest amount of data specific to you and allows a server to deliver a page tailored to you on your computer, hard drive, smartphone or tablet (hereinafter referred to as, "Device"). 10.2 Types of cookies according to the length of time you stay connected:

Depending on the amount of time you remain active on your Device, these are the following types of cookies:

persistent cookies on our Website is 2 years. At this point the browser would purge the cookie from the hard drive.

a. Technical cookies: these cookies are strictly necessary for the operation of our Website and are essential for browsing and allow the use of various features. Without them, you cannot use the search function, compare tool or book other available services on our Website.

b. Personalisation cookies: these are used to make navigating our Website easier, as well as to remember your selections and offer more personalised services. In some cases, we may allow advertisers or other third parties to place cookies on our Website to provide personalised content and services. In any case, your use of our Website serves as your acceptance of the use of this type of cookie. If cookies are blocked, we cannot guarantee the functioning of such services.

c. Analytical cookies for statistical purposes and measuring traffic: these cookies gather information about your use of our Website, the pages you visit and any errors that may occur during navigation. We also use these cookies to recognise the place of origin for visits to our Website. These cookies do not gather information that may personally identify you. All information is collected in an anonymous manner and is used to improve the functioning of our Website through statistical information. Therefore, these cookies do not contain personal data. In some cases, some of these cookies are managed on our behalf by third parties, but may not be used by them for purposes other than those mentioned above.

d. Advertising and re-marketing cookies: these cookies are used to gather information so that ads are more interesting to you, as well as to display other advertising campaigns along with advertisements on the Website or on those of third parties.
